

Notification to Fishermen

Nord Stream 2 Project

28.06.2019

1. Purpose of this notification

Nord Stream 2 AG hereby submits a notification for the activities to be performed for the Nord Stream 2 Project in July 2019.

During this period, pipelay will continue in the Finnish EEZ towards Russia with *Pioneering Spirit*. *Solitaire* will lay the pipeline in the Swedish EEZ in a southerly direction from east of Gotland.

Nord Stream 2 AG reminds that the construction vessels have limited manoeuvrability while performing their work and that safety exclusion zones are therefore established around the vessels carrying out the Nord Stream 2 activities.

3. Duration and locations of activities

In July, **rock placement** activities of short duration will be carried out with *Bravenes* in the Finnish and Swedish EEZs at various locations along the Nord Stream 2 route.

Pipelay will continue in the Finnish EEZ towards Russia with *Pioneering Spirit*. *Solitaire* will lay the pipeline in the Swedish EEZ in a southerly direction from east of Gotland. The pipe supply vessels will shuttle to the pipelaying vessels from the pipe logistics bases in Karlshamn for the Swedish operations and Kotka for the Finnish operations.

In addition, *Oceanic* will perform mattress installation works of short duration in the Swedish jurisdiction, not far from the Swedish-Danish EEZ border.

The map below illustrates the foreseen July activities. Please note that these details are subject to change for operational reasons.

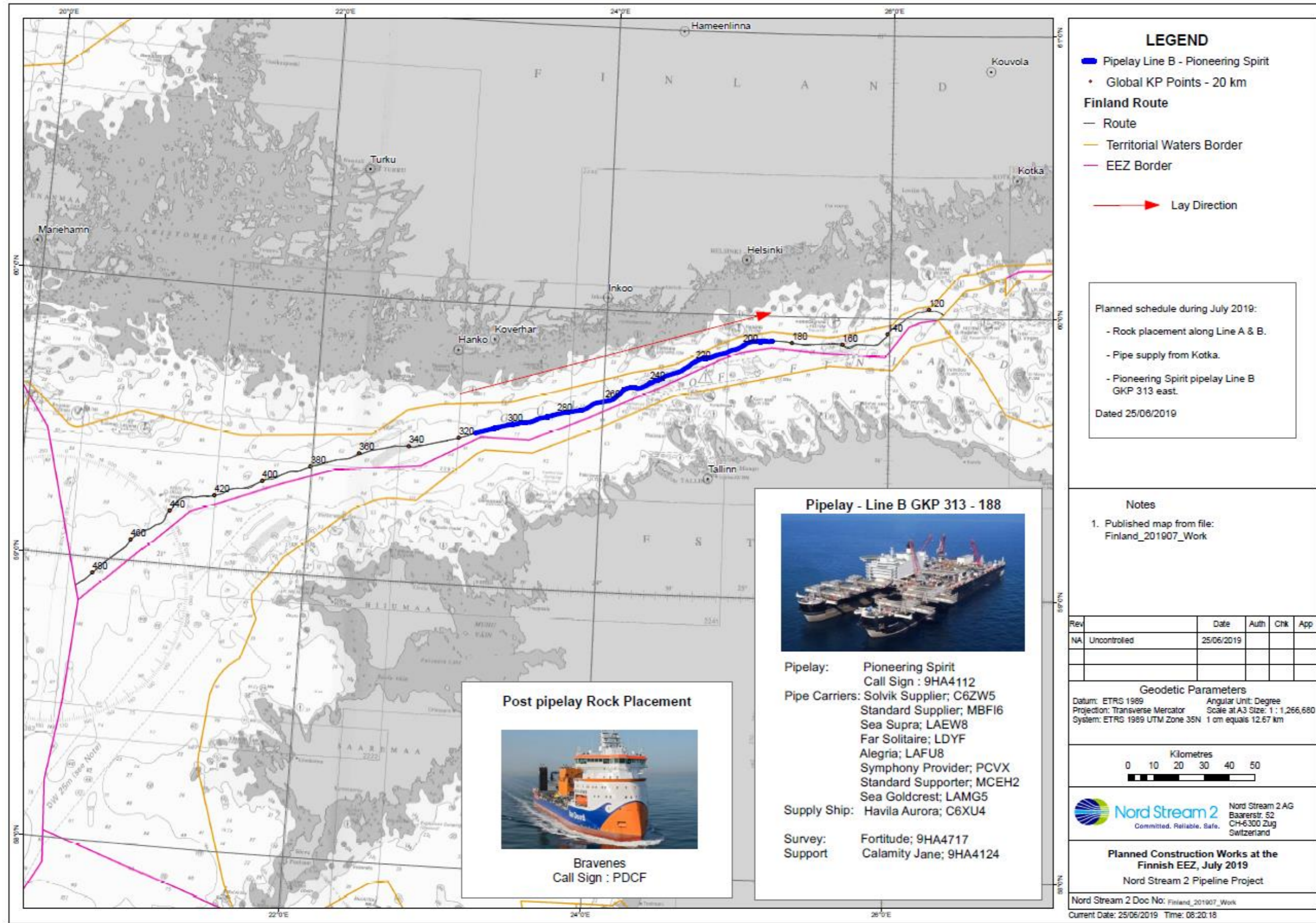


Figure 1: Nord Stream 2 construction activities in July in the Finnish EEZ

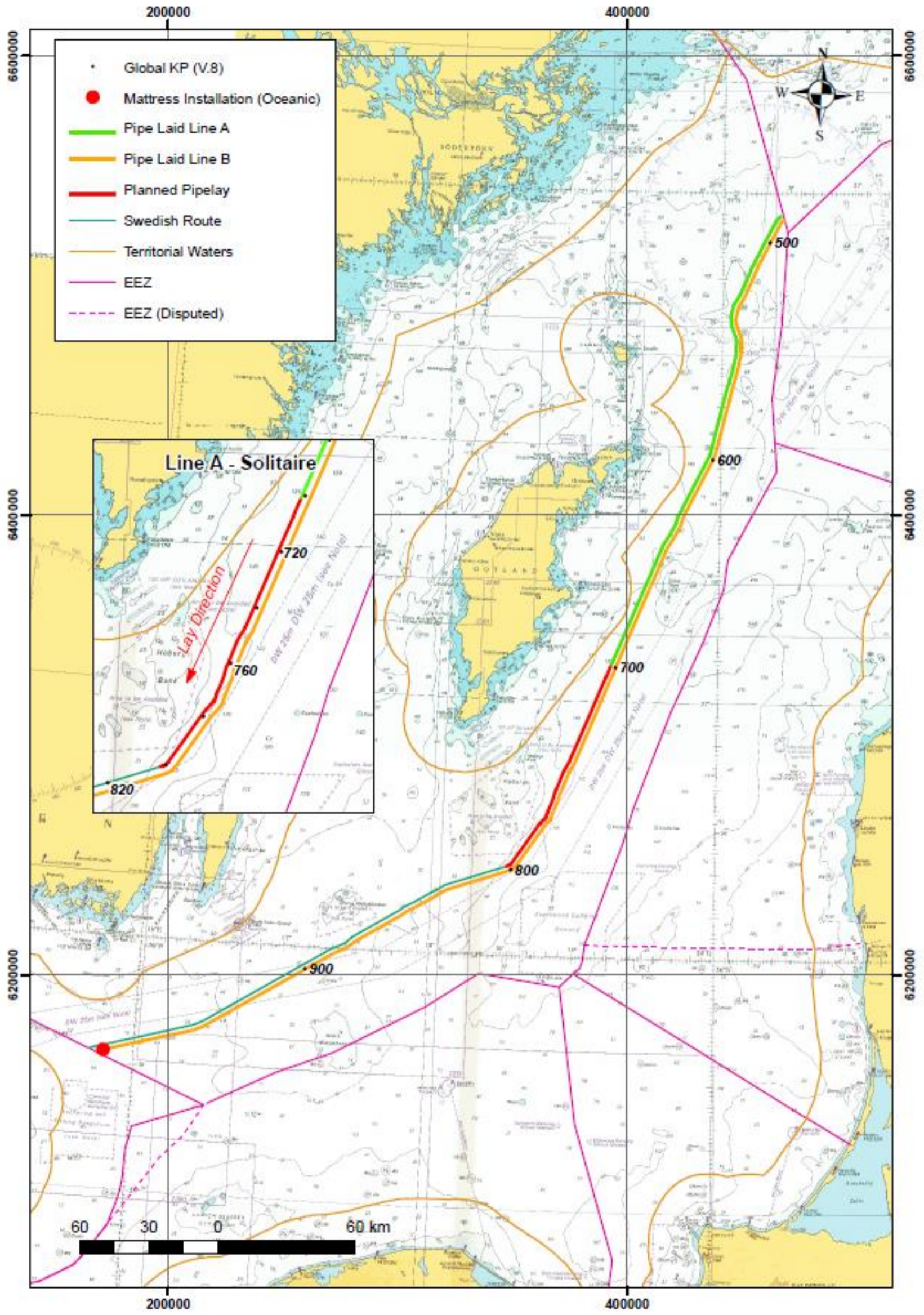


Figure 2: Nord Stream 2 construction activities in July in the Swedish EEZ

4. Exclusion Zones

Nord Stream 2 AG would like to highlight that a safety zone of 1 nautical mile is established around the pipelaying vessels *Solitaire* and *Pioneering Spirit*, and 500 meters around the other vessels performing activities for Nord Stream 2 Project.
