

Notification to Fishermen

Nord Stream 2 Project

1. Purpose of this notification

Nord Stream 2 AG hereby submits a notification for the activities to be performed for the Nord Stream 2 Project in August 2019.

During this period, pipelay will continue in the Finnish EEZ towards Russia with *Pioneering Spirit*. No pipelay activities will be carried out in the Swedish EEZ.

Nord Stream 2 AG reminds that the construction vessels have limited manoeuvrability while performing their work and that safety exclusion zones are therefore established around the vessels carrying out the Nord Stream 2 activities.

Rock placement in Finland (and possibly Sweden):

3. Duration and locations of activities

In August, **rock placement** activities of short duration will be carried out with *Bravenes* in the Finnish and possibly Swedish EEZs at various locations along the Nord Stream 2 route (but outside of the Natura 2000 area in Sweden).

Pipelay will continue in the Finnish EEZ towards Russia with *Pioneering Spirit*. The pipe supply vessels will shuttle to the pipelaying vessel from the pipe logistics base in Kotka.

Pioneering Spirit is forecasted to leave the Finnish waters and enter into the Russian jurisdiction in the second half of August.

The map below illustrates the planned August activities. Please note that these details are subject to change for operational reasons.

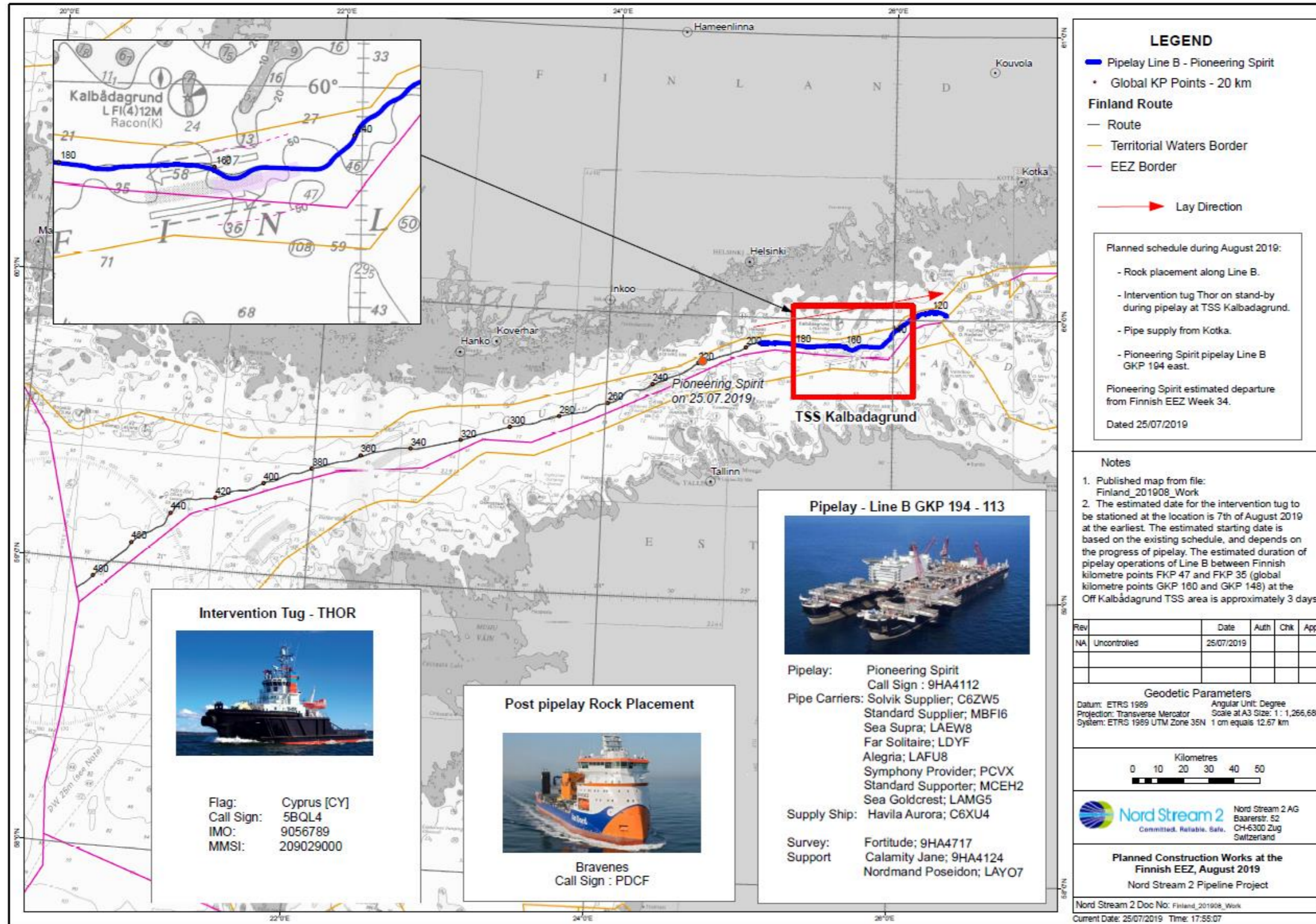


Figure 1: Nord Stream 2 construction activities in August in the Finnish EEZ

4. Exclusion Zones

Nord Stream 2 AG would like to highlight that a safety zone of 1 nautical mile is established around the pipelaying vessel *Pioneering Spirit*, and 500 meters around the other vessels performing activities for Nord Stream 2 Project.
